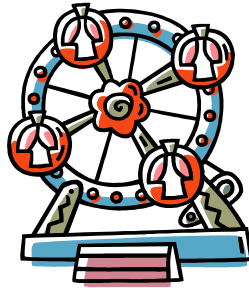

# **RULES, REGULATIONS & DEFINITIONS**

## **DEFINITIONS:**

**Food Booth:** Any vendor of food products whether company, person, or organization who sells food to make a profit for themselves or any organization.

**School Group:** Only groups or organizations that are affiliated with Lathrop R-II, i.e.: FCCLA, FFA, Classes, etc. **Soda pop may not be given away.**

**Church Group:** Only groups that are affiliated with churches inside the Lathrop City limits. This **DOES NOT** include churches operating food booths. **Soda pop may not be given away.**

**Vendor Booths:** An arts and crafts booth is defined as a booth that offers for sale only hand made crafts made by the booth holder or his/her family. Any direct sales company.

**Events Group:** Any group who sponsors a sporting event, ride, etc.

## **RULES & REGULATIONS:**

**Food Vendors:** Cooking grease and oil cannot be dumped in city drains and must be put into containers and removed from the festival and downtown area. **Restrictions include: NO funnel cakes or cotton candy to be sold by any vendor other than carnival.**

**Electricity:** Vendors needing electricity must provide heavy three conductor cords. At least 200 feet is recommended. A ladder to reach electrical outlets is also recommended. **The Lathrop Friendship Festival Corporation is not responsible for providing cords or ladders.**

**Set Up Time:** Vendors will be permitted to begin booth assembly at 4:00 P.M. on Thursday or Friday. Saturday vendors can start setting up at 7:00 A.M. Please **DO NOT ARRIVE EARLY TO SET UP!** There will be no booth holder vehicles parked inside the barricades at any time during the operating hours of the festival.

**Payment:** All money for booth spaces **MUST** be received prior to set up on the festival grounds. Anyone failing to do so will be asked to remove their booth.

**Booth Location:** The Lathrop Friendship Festival Corporation will place your booth in the location that best benefits the layout of the festival. Vendors may request certain booth locations, but are not guaranteed that they will receive that location.

**Refunds:** To be eligible for a refund, cancellations must be made in writing no later than June 15, 2016. A refund of 50% will be made if the booth space is resold before the festival. NO refunds will be made after July 1st, 2016. NO refunds will be given due to weather.

**Inclement Weather:** In the event of inclement weather during the festival, it is the responsibility of the vendor to secure their booth and its contents. The Lathrop Friendship Festival is NOT responsible for booths or items that are damaged due to inclement weather.

**Application Process:** Applications for booth spaces will not be processed without all fees being paid in advance. A \$30.00 fee will be charged for all non-negotiable checks.

**Credit Card Payments:** \$5.00 processing fee will be charged. Return signed contract via email to Sgoad042005@yahoo.com, to receive invoice.

**Please understand that we have activities all day on Saturdays, it is up to you if you open at 10 am or 4 pm. Please note that there will be no way to exit the street earlier than 8 pm on Saturday night.**

**The Lathrop Friendship Festival Committee** is authorized and empowered by The Lathrop Friendship Festival Corporation to organize and manage the festival and to enforce the rules and regulations for conduct and safety of the festival. Decisions made by the committee are nonnegotiable! **The committee reserves the right to revoke a booth permit at any time, not refund the fees and forfeit all future rights to entry.**
